Liberia provides lead on BWM convention amendment

The Liberian Maritime Administration is leading a proposal to allow certain ships additional time beyond 2020 to install adequate ballast water management systems as required under the Ballast Water Management Convention, which comes into force in September 2017.

The current IMO guidelines are not sufficiently detailed to ensure that BWM systems have been adequately challenged to provide the necessary confidence that they will meet the required discharge performance standard. Liberia and other industry representatives at the October meeting of the IMO Marine Environmental Protection Committee (MEPC) in London were able to garner sufficient support to re-visit the installation deadline through alternative proposals to amend the convention.

David Pascoe, Senior Vice-President, Operations & Standards at the Liberian Registry, says, "The revised approval guidelines are expected to be roughly aligned with the robust type-approval regime of the United States. But there are no BWM systems currently approved by the U.S., and it could take several years for equipment approved under the new IMO guidelines to be readily available for installation. In the meantime, tens of thousands of ships may be

required to install existing systems that may not fully comply with the convention standards.

"In order to allow more time for new systems to become available and for shipowners to decide which system to invest in and install, Liberia has proposed that shipowners may decide if they wish to renew a ship's IOPP certificate earlier than scheduled in order to have an additional 4-to-5 years to see if new equipment becomes available.

"It is by no means certain that adequate new systems will be commercially available in sufficient quantities within this period, and the dockyard capacity to fit systems on board ships will fall well short of peak demand, expected to occur in 2020-2021.

"It would therefore seem reasonable not to require continued installation of BWM systems which have not been approved under the new guidelines and to allow certain ships additional time beyond 2020 in order to ensure that adequate new systems are commercially available, along with the necessary dockyard space for installation."

The next MEPC meeting, at which Liberia's proposal will be considered, is scheduled for the first-half of 2017.

Liberia says flag states must be more than certification factories

Afonso Castillero, Vice-President of the Liberian Registry, told a recent Port State Control seminar in Tokyo, "In the current difficult market conditions, flag states can no longer afford to regard themselves as mere factories for issuing registration certificates. It is necessary to evolve and to embrace new challenges. Shipping registers need to combine quality and innovation with tradition, experience, reputation and flexibility."

The objective of the seminar, which was attended by representatives of the Australian Maritime Safety Agency (AMSA), was to promote among clients of the Liberian Registry a clear understanding of the Port State Control process in Australia, so that owners, operators, and managers can achieve full compliance with – and facilitate efficient inspections under – Australia's PSC regime.

Benson Peretti, Managing Director of the Liberian Registry's Singapore office, outlined for the seminar the Liberian Registry's PSC results for the year to date, showing a major reduction in detentions in China, Australia, and the United States, thanks in large part to the free compliance assistance programmes being implemented by Liberia. And Takeshi Okamoto, General Manager of LISCR Japan, explained how and why the Liberian Registry is leading the global campaign to seek an extension to the implementation date for the Ballast Water Management Convention.

The seminar was attended by over one hundred industry professionals, including Liberian flag clients and potential clients looking to switch flags or register new vessels under the Liberian flag. The mood of the seminar was summed up by the chief executive of one leading Japanese shipowner who emphasised, "We must comply with all international regulations, and that is why we need a flag that will always stand beside us."

★ When a three-year-old, 33,000 gt Liberian-flag bulk carrier was recently detained in a French port, one of the Registry's inspectors boarded the vessel in order to verify or challenge the on-board non-conformities which had been noted. Liberia's inspector was able to prove to the satisfaction of Rightship inspectors that the detention was not valid, and the vessel was duly released, with its five-star rating restored.

Liberia trials class and statutory e-certificates on ClassNK ships

The Liberian Registry has launched operational trials for electronic certificates covering both statutory and class regulations.

Having initiated the practice of issuing electronic statutory certificates such as Minimum Safe Manning, Civil Liability Convention and Registration Certificates for several years, the Liberian Registry has now started trials on ships classed by Japanese classification society ClassNK for the statutory certificates that it issues on behalf of Liberia. The new e-certificates will have a two-fold benefit for owners and operators. They will significantly reduce the administrative burden associated with handling and managing traditional paper certificates, while facilitating the onboard retrieval of certificated data.

The Liberian Registry began issuing electronic certificates in respect of regulatory compliance in a format developed in accordance with the updated

Guidelines for the Use of Electronic Certificates issued by IMO. Once again, it provided an industry lead in this respect, as it has done now with the extension of the e-certificate initiative to include class requirements.

Scott Bergeron, CEO of the Liberian International Ship & Corporate Registry (LISCR), the U.S.-based manager of the Liberian Registry, says, "Liberia's intention is always to make regulatory compliance easier and more cost-effective for shipowners and operators. Look at what we have been doing for years in terms of harmonizing ISM and ISPS audits, for example.

"Starting to move towards a system based on the use of e-certificates which can be verified online is the logical next step in the technological transformation of ship registration, and indeed of shipping generally. It will also help to reduce the incidence of fraud and manipulated data.

Liberia hosts shipmanagement seminars in Japan

A number of leading shipowners, managers and operators attended three recent ship management seminars in Japan organised jointly by the Liberian Registry, RightShip and ClassNK. The seminars were held in Tokyo, Kobe and Imabari.

LISCR's presentations covered every aspect of the Liberian Registry's services, including the extended drydocking programme, the recent initiative on China port dues, and the new oil record book software. RightShip was able to provide an update on predictive analysis and its next-generation vetting tool, RightShip Qi, as well as Greenhouse Gas Emissions Rating. ClassNK, meanwhile, covered topical issues arising out of the Port State Control regime.

Another successful ISM/ISPS auditor course in Greece

The Liberian Registry completed another back-to-back ISM/ISPS Flag Auditor and MLC 2006 Flag Inspector Course in Piraeus, Greece, where 27 candidates trained to become ISM-ISPS Auditors, and 25 to become Maritime Labour Inspectors. Participants in the courses constituted new and current inspectors from Australia, New Zealand, USA, Uruguay, Saudi Arabia, Germany, Ivory Coast, Taiwan, Philippines, Pakistan, China, Brazil, India, Luxembourg, Egypt, Mexico, and the UAE.

As with previous courses, the ISM-ISPS course discussions and lectures were facilitated by both Mike Symons and Al Romero. The ILO-MLC 2006 Inspector Course, meanwhile, was conducted by Cedric D'Souza and Al Romero. Overall, the objective of providing efficient and supervised training to Liberia's inspectors and auditors was successfully met.
